## AN ACT TO CREATE LUKAMBEH ADMINISTRATIVE DISTRICT WITHIN LOFA COUNTY, REPUBLIC OF LIBERIA

WHEREAS, Lukasu and Hembeh clans comprise of a population of Twelve Thousand Nine Hundred Forty-four (12,944) inhabitants (2008 National Housing and Population Census Report); and has an approximate area of Two Thousand Two Hundred Twelve (2,212) square kilometer;

WHEREAS, responding to the development needs of the growing population in the district will require an efficient and responsive Administrative District leadership;

Realizing that development is accelerated when large areas are segmented and administered into smaller parts;

Recalling that, Article 34(a) of the 1986 Constitution of Liberia empowers the National Legislature to create new counties and other political sub-divisions and readjust existing counties;

# NOW THEREFORE:

It is enacted by the Senate and House of Representatives of the Republic of Liberta in Legislature assembled:

#### Section I: Creation of the Administrative District

That from and immediately upon the passage of this Act, the two clans comprising Lukasu and Hembeh within Kolahun District, Lofa County, Republic of Liberia, shall be created as Lukambeh Administrative District with headquarters in Passowolahun; and in such name, it may sue and be sued plead and be impleaded, and do all other acts that are usually done by similar corporate bodies.

### Section II: Metes and Bounds of the District

That Lukambeh Administrictive District shall have the jurisdiction within its corporate bound, said corporate been approximately 2,212 square kilometers constituting two class which mete and bound are:

- A)Bounded on the north by Wanwona and Tahamba Clans of Kolahun District, on the northeast by Bondi Clan of Voinjama District, on the southeast by Buluyeama Clan of Zorzor District, on the South by Gbarpolu County, on the southwest by Hassala Clan of Kolahun; and,
- B) That the Administrative District shall be headquartered in Passowolahun.

## Section III: Power and Authority of the Administrative District

That Lukambeh Administrative District shall the full power and authority to make and fulfill contracts, take real properties as in the case of any other administrative in the Republic of Liberia.

# Section IV: District Administration

That the president of the Republic of Liberia shall nominate and with the consent of the Senate, appoint a District Commissioner and all other officials necessary for the governance of the Administrative District.

# Section V: Authority of the President

That the President of the Republic of Liberia is hereby authorized and empowered to put into immediate effect and to execute all appropriate and necessary measures for the organization, functions and political representation subject to constitutional requirements of the Administrative District hereby created, declared and established.

## Section VI: Effective Date

This Act shall take effect immediately upon publication into handbill.


