**JOINT ADMINISTRATIVE REGULATION
NO.08.2113-1/MFDP/LNTA/25 MARCH 2026**

TO : THE GENERAL PUBLIC

**SUBJECT : OFFICIAL FEE STRUCTURE FOR LIBERIA
NATIONAL TOURISM AUTHORITY**

DATE : 25 MARCH 2026

1. GENERAL RULE

Ministry of Finance & Development Planning (MFDP) is responsible for the formulation of fiscal policies to enhance economic growth and stability, and to govern taxation pursuant to the Revenue Code of Liberia.

In keeping with section 2200 of Liberia Consolidated Revenue Code of 2021 as amended, the Minister shall make policy regulations prescribing anything which is to be prescribed under and generally for carrying out the provision of this code.

2. LEGAL BASIS

Section 2113 of Liberia Consolidated Revenue Code of 2021 as amended Annual Fees- Liberia National Tourism Authority The fees and levies for services and activities of the Liberia National Tourism Authority shall be by published regulation prescribed from time to time by the Director General of the Liberia National Tourism Authority in consultation with the Minister of Finance & Development Planning, and shall be regularly assessed by the Liberia National Tourism Authority and be paid regularly to the Commissioner General for deposit into the account of the Government.

3. PURPOSE

This Administrative Regulation is an instrument to govern the services & activities provided by the Liberia National Tourism Authority promulgating the official fee structure for services & activities of the Liberia National Tourism Authority.

4. PROCEDURE NOTICE

This Administrative Regulation hereby institutes the empowerment of the Liberia National Tourism Authority to regulate and assess services & activities fee from an applicant who then proceeds to the designated Liberia Revenue Authority (LRA) collection window for onward deposit into the consolidated fund in accordance with section 7 of the Liberia Consolidated Revenue Code of 2021 as amended.

5. IMPLEMENTATION NOTICE




