JUDGMENT WITHOUT OPINION

When this case was called for hearing, Counsellor Nyenati Tuan of Tuan Wreh Law Firm appeared for the movants/appellees. Counsellor Thompson N. Jargba of the Law Offices of Jargba & Jargba appeared for the respondents/appellants.

Following the Court's notation of representation by the parties, counsel for the movants/appellees asked leave of Court and was granted permission by the Court to make a submission upon the records of the Court, wherein he called the Court's attention to a motion to dismiss the appeal filed by the movants/appellees. The motion averred that while the respondents/appellants had complied with the statutory time for filing of documents for the completion of their appeal, they had failed to exhibit a valid tax clearance in support of

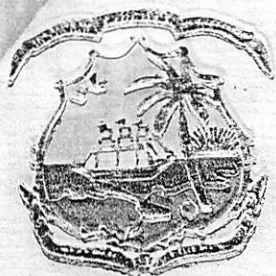

the appeal bond, as required by law. This defect in the appeal bond, the movants said, deprived the Supreme Court of jurisdiction to hear the appeal on the merits.

A review of the records showed that contrary to the allegations made by the movants, the respondents had indeed complied with all of the statutory requirements for the taking and completion of an appeal to this Court and that the appeal bond did not show defect warranting the dismissal of the appeal. This Court notes, and as confirmed by counsel for the movants, that the surety to the respondents appeal bond had in fact complied with the standards relative to the validity of an appeal bond as articulated in various cases decided by this Court, including the annexation of a valid business registration document, the surety's articles of incorporation authorizing the insurance company to serve as surety to appeal bonds in this Republic, and exhibition of a valid certificate from the Central Bank indicating the financial viability of the surety to the respondents/appellants' appeal bond.

The movants' counsel, not having challenged the authenticity of the certificate from the Central Bank of Liberia attesting to the financial viability of the respondents/appellants' surety, a dismissal of the appeal on the ground that at the time of execution of the appeal bond, the date stated on the tax clearance had expired is deemed by this Court to be a mere legal technicality that does not affect the validity of the bond to warrant dismissing the appeal. It is that law that *"the intent of the Legislature in passing the Act setting the grounds for dismissing an appeal was primarily to discourage the dismissal of appeals on technical grounds and to give the appellants an opportunity to have their cases heard by the Supreme Court on their merits."* *Forestry Development Authority v. Forestry Development Authority Workers Union (FDAWU)*, 39 LLR 684 (1999); *Hussenni v. Brumskine*, Supreme Court Opinion, March Term, A. D. 2013.

Accordingly, and in view of the foregoing, it is hereby
