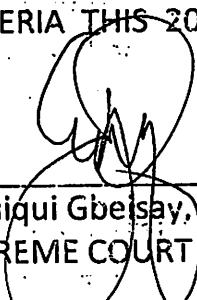

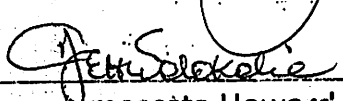

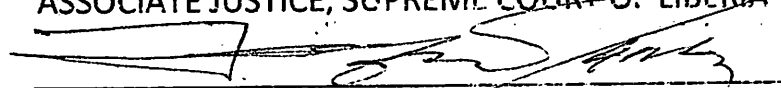
ADJUDGED:

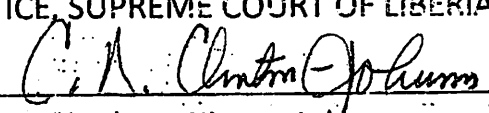

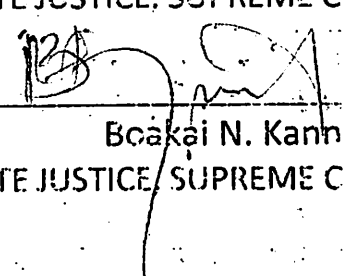
